2. Apologies of Absence were received from Cllr Alia Lewis MBE, Cllr Beryl Warner BEM, Cllr Ann Kennedy, Cllr Henry Klijn and Cllr Iris Thomas.

3. Declaration of Interest was received from Cllr Glyn Haynes and Cllr Trefor Lloyd Hughes for item 9A and 9B on the agenda as they are part of the planning committee for the Isle of Anglesey County Council. Cllr Hywel Williams also declared an interest in item 9.A on the agenda. the councillors above did not take any votes on the planning consultations.

4. The minutes of the previous meeting held on the 7<sup>th</sup> November 2022 were *proposed, first and seconded of a true record*. *Minute no. 5514/2022*

5. Presentation from Joseff and Dylan Isle of Anglesey County Council AONB Wardens: Isle of Anglesey County Council have been successful in securing a three-year Welsh Government Capital Funding to conserve and enhance natural beauty. Empty land behind Ysgol Morswyn will be used to conserve a tree nursery and 13 allotments, and an area in the breakwater country park will be used to create an outdoor classroom along with a sensory garden with the initiative to work alongside local schools to be maintained in the future. The allotments will firstly be offered to the local schools and then to any residents in the area to avoid a build-up in traffic around the area and in the hope that they will sufficiently run themselves in the future.
